Each eligible member may submit up to three (3) framed photographic prints either color or B&W at least 8" x 10", but not larger than 16" x 20" in size, suitably mounted or framed, wired and ready to be hung.

Alternately, two prints 24" x 30" or one (1) larger print around 30" x 40" may be submitted. Montages, etc. may be submitted provided they occupy similar spaces.

For each print submitting for exhibition complete the Entry Form in triplicate (see page 3): 1 Copy Submit with your payment, 1 Copy Attach to the back of your print(s); 1 Copy you keep as your receipt.

As space is limited, submissions will be accepted on a first come, first serve basis. If unfilled wall space is available during hanging, consideration will be given to a limited number of additional prints at a **\$15** charge.
